Call for Resident and Fellow Abstracts for Poster/Oral Presentations Deadline: March 17th 2024

The following guidelines have been adapted from the 2017 ACR Abstract guidelines:

- Submission of an abstract constitutes a commitment by the one of the authors to attend the annual meeting and address attendee questions if the abstract is accepted. Authors must be in attendance during the Resident/Fellow poster presentation session on Sunday morning (May 19th).
- Abstracts must be sent by email to the GRS Education and Program Committee c/o Ryan Peterson (ryan.peterson@emory.edu).
- Category of abstracts include a) **Scientific** or b) **Educational exhibit**.
 - Scientific abstracts must be formatted and organized into the following four sections: 1) Purpose, 2) Methods/Materials, 3) Results and 4) Conclusions.
 - Educational exhibit abstracts need to provide: 1) Purpose, 2) Outline of cases/pathology to be discussed, and 3) Sample PowerPoint slides (up to 3) illustrating the image quality.
- Abstracts must be based on original, completed research projects OR be an original educational exhibit — not previously published or presented at other regional or national meetings; case reports will not be considered.
- Scientific abstract submissions are limited to 2000 characters (total of all sections including Purpose, Materials/Methods, Results and Conclusions), 1 image and 1 table. Educational exhibit abstracts are limited to 1500 characters for parts 1 and 2, and 3 PowerPoint sample slides (slides excluded from character count). Spaces count toward character limit.
- Abstracts must be balanced and contain no commercial promotional content. Brand names of pharmaceuticals and trade names of medical devices cannot be used in the title or body of the abstract.
- An abstract may only be submitted once: duplicate abstracts (reporting the same data) that are submitted under a different title or author will not be considered.

Deadline for Abstract submission is March 17^h 2024 (Sunday). Abstract disposition will be sent by email to the first author no later than March 24th 2024 (Sunday). Notification for confirmation of acceptance of poster/oral presentation will be March 31st 2024 (Sunday).

If accepted, a poster detailing your work should be 3x4 feet in size and **mounted on a foam board** for display on an easel. Oral presentations will be 5-10 minutes in length using PowerPoint format if applicable. You will be notified of the format the educational committee is requesting. Registration for the conference and membership is free for trainees but lodging, travel and food is at the expense of the resident/fellow or (hopefully) their home institution. Please remember to honor HIPPA guidelines and assure that the content of all presentations submitted to the meeting is in compliance with the Health Insurance Portability and Accountability Act of 1996 (HIPAA) and the U.S. Department of Health and Human Services a regulation implementing this act. To comply with HIPAA regulations, patient confidentiality must be maintained in all presentations.
